

# Event Report on "Interactive Seminar on Food Processing"

Date: 6th March, 2019 Venue: Niryat Bhawan, Qaiserbagh, Lucknow

# Background

Interactive Seminar on Food Processing was held with the aim of spreading awareness about government schemes for promotion of Food Processing sector, ODOP scheme, and financial aid/loans. Entrepreneurs and workers functioning in food processing sector across nine ODOP districts of Uttar Pradesh discussed their experiences in the Seminar & had an opportunity to have an interactive session with government officials & industry representatives.

## **Theme & Participating Districts**

Theme of the seminar was Food Processing industries & ODOP food products like Desi Ghee (Auraiya), Pulses (Bulrampur & Gonda), Jaggery (Ayodhya & Muzafarnagar), Banana (Kaushambhi) Kala Namak Rice (Siddharth Nagar), Aamla (Pratapgarh) and Hing (Haathras) were covered in seminar.

## **Inauguration of Seminar**

The event was **inaugurated by Shri Sudhir Garg, Principal Secretary,** Horticulture & Food Processing, Sports & Youth Welfare and DG, Youth Welfare & Prantiya Rakshak, Government of Uttar Pradesh (GoUP). The event was presided over by Shri K. Ravindra Naik, Commissioner and Director, Directorate of Industries, GoUP. Additionally, key officials of ODOP Cell participated in the event along with officials of Horticulture & Food Processing Department of GoUP, Agriculture Department of GoUP, NABARD, Bank of Baroda, Yes Bank, Parag Dairy, Gyan Dairy, Indian Institute of Sugarcane Research (IISR), Regional Food Research and Analysis Centre (R-FRAC) and Mandi Samiti.

#### **Keynote Speaker**

Principal Secretary, Shri Sudhir Garg, Horticulture & Food Processing, Sports & Youth Welfare and DG, Youth Welfare & Prantiya Rakshak. GoUP- He highlighted various schemes of the State and Central Government for Food Processing sector. He emphasized on the need to treat local farmers and Agri-entrepreneurs at par with industrialists. Further, he highlighted the immense potential of food processing industry in the State and urged entrepreneurs to work on improving the quality



and shelf life of their products so that they can be sold nationally and internationally. In last, he invited entrepreneurs to take advantage of the State's Food Processing policy 2017 that offers grant-in-aid of up to 35% including Government of India's grant-in-aid of 10%.



## **Knowledge & Experience Sharing by Dignitaries**

**Dr. Atul Kumar, Joint Director, Horticulture and Food Processing Department, GoUP:** He intimated the participants about various schemes of Horticulture and Food Processing Department of GoUP for Banana and Sugarcane production, their application process through online medium and policy of first-come, first-serve for incentive distribution. He invited audience to capitalise on these schemes to start/expand their businesses.

**Dr. Vijay Yadav, Deputy Director. Horticulture and Food Processing Department, GoUP:** He explained about various subsidies and incentives offered by the State Government for entire food processing sector. Key incentives highlighted included capital subsidy, transport subsidy and rebate on preparing DPRs.

**Dr. Shabnam Chopra, General Manager, Quality, Parag Dairy:** She highlighting the importance of Desi
Ghee and its nutrient value. Additionally, she stressed on
the pain points faced by the sector like bringing down the
GST on Desi Ghee from 12% to more sustainable/
competitive level.

**Samiti:** He highlighted the various rebates offered by Mandi Samiti to farmers and entrepreneurs engaged in food processing sector. He also intimated the participants about organic products mela organised at Lucknow. He encouraged and invited the participants to produce organic food and visit/ participate in organic products mela at Lucknow, respectively

**Dr. S. K. Chouhan, Director, R-FRAC:** He highlighted the importance of quality checking in food processing sector. Additionally, he invited the entrepreneurs for availing the services of R-FRAC for quality checking.

# **Experience Sharing by Entrepreneurs**

Along with professionals, entrepreneurs also shared their experience related to the products they are producing. Entrepreneurs shown their interest in handholding provided by State Government for improving the quality and packaging of their products, access to finance, marketing assistance and branding assistance. Few entrepreneurs



also inquired about setting up of Common Facility Centre in their districts.



# **Closing Session**

Shri K. Ravindra Naik, Commissioner and Director, Directorate of Industries, GoUP concluded the session by emphasising on various ODOP schemes launched by the State Government including Margin Money Scheme, Marketing Development Assistance Scheme and Common Facility Centre Scheme. He also talked about dovetailing various Central and State Government schemes with ODOP schemes. Further, he assured the participants of creating an enabling ecosystem for ODOP products in the State through progressive policies, schemes and required infrastructure.

- Regarding required infrastructure, he highlighted the requirement of Testing Labs and CFCs which would be created through a well laid out process that has already been started Diagnostic Study Reports (DSRs) are at various stages of completion across all the districts of Uttar Pradesh; In fact some DSRs have already been submitted to DIEPCs. For creating more food processing parks, he intimated the audience that the State Government is working on a policy of smaller (approximately 20 acres size) parks.
- He encouraged entrepreneurs to participate in national and international promotional events to promote their products and avail 75% subsidy in the form of reimbursements towards stall changes, freight charges and travel charges, among others. In the end, he thanked all the participants for taking part in the seminar.

## **Key Outcomes of the Seminar**

- Strengthened the branding of ODOP initiative through detailed discussions.
- Dissemination of critical information like availability and eligibility for financial assistance for the food processing units in the state of <u>U</u>ttar Pradesh by government officials & leading banks.
- Common platform for discussion & interaction for creation of conducive ecosystem among the stakeholders including the entrepreneurs, bank representatives and government officials.
